Our New Fund SOMC Nursery Bereavement Fund

Tens of thousands of families across the United States are devastated each year by the loss of their newborn. The SOMC Development Foundation created the Nursery Bereavement Fund to help relieve the pain families experience following the loss of a newborn.

This fund is used for education/training for our staff to equip them with the knowledge needed to provide the “Gold Standard of Care” for families experiencing an unexpected perinatal loss. It also provides resources for the mothers and families such as Perinatal Bereavement Kits, pamphlets, books, keepsake impressions, keepsake memory box, photo access and burial outfits as well as a possible burial fund for families who are experiencing an additional financial stress or burden with burial expenses.



Coat Drive Success

After much generosity and an abundant amount of compassion from our community, local schools and shelters received new winter coats of all different sizes, plus hats, gloves and socks for those in need this winter.

Feed Our Frontline Campaign

Our heroes work on the frontlines and spend long hours away from their families to take care of all of us. They may often miss meals or are just too tired to think about eating. Luckily, our heroes have their own hero: you. This campaign was created specifically because our community wanted to give back to our frontline staff.

Thanks to the generous donations of our community, the SOMC Development Foundation purchased gift cards to local restaurants to distribute to those brave healthcare heroes.



COVID-19 Emergency Response Fund

During the midst of the COVID-19 pandemic, we were all struggling with the necessity to shelter in place and keep our distance during this unprecedented crisis. Many of us were also wondering how we can help those who will take care of us if we get sick. The SOMC Development Foundation created a fund that is designed specifically to help those who are helping us: the COVID-19 Emergency Response Fund.

Donations to the fund helped purchase protective equipment for our frontline healthcare workers and sanitizing items to fight the spread of COVID within the hospital. Just as importantly, the fund addresses the new struggles our healthcare heroes are facing personally as they spend long and dangerous hours taking care of our patients.
