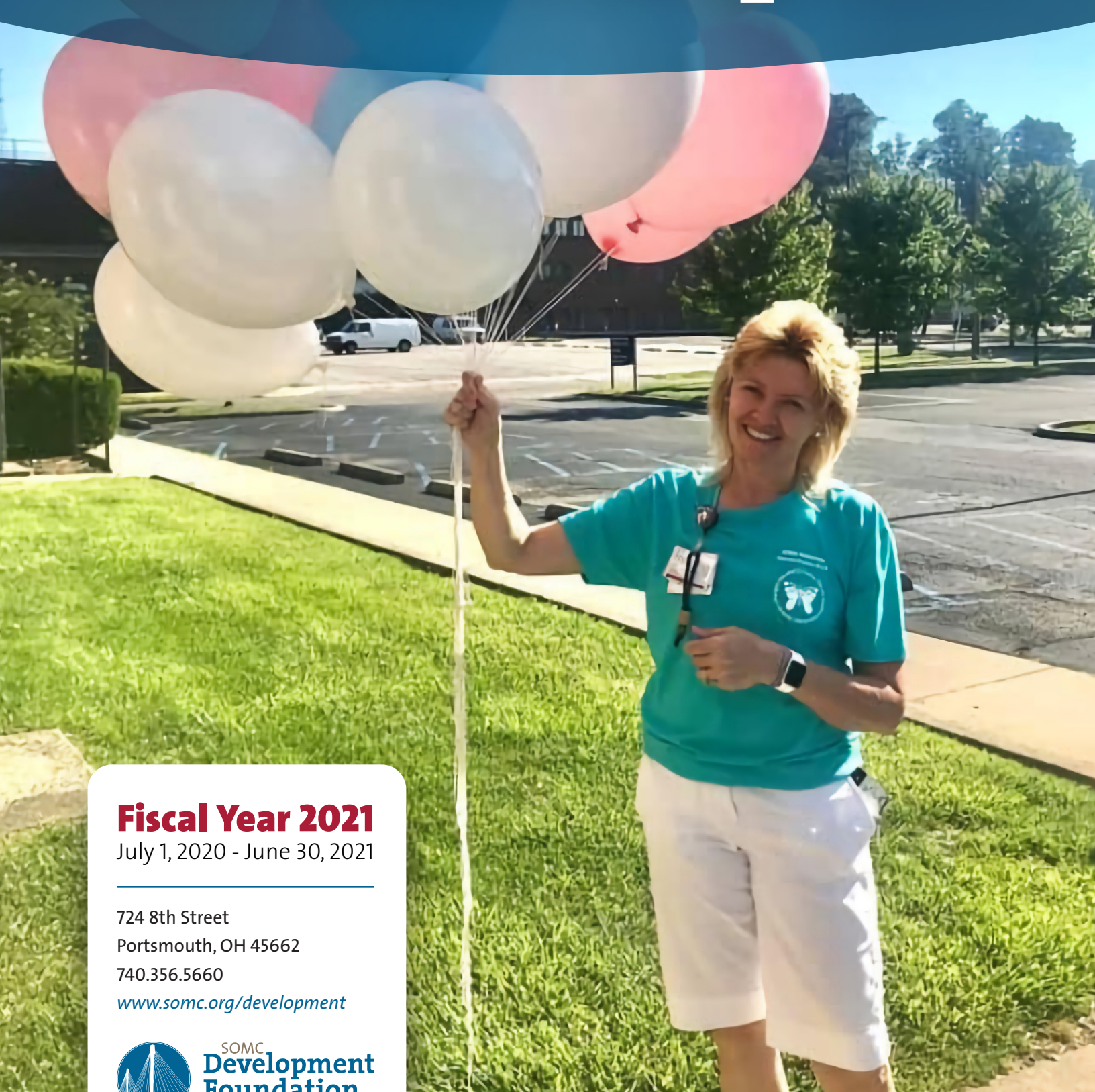

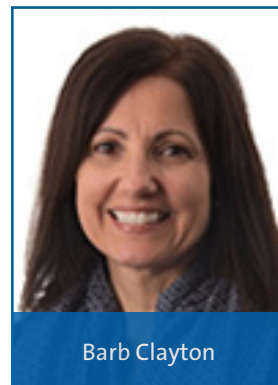

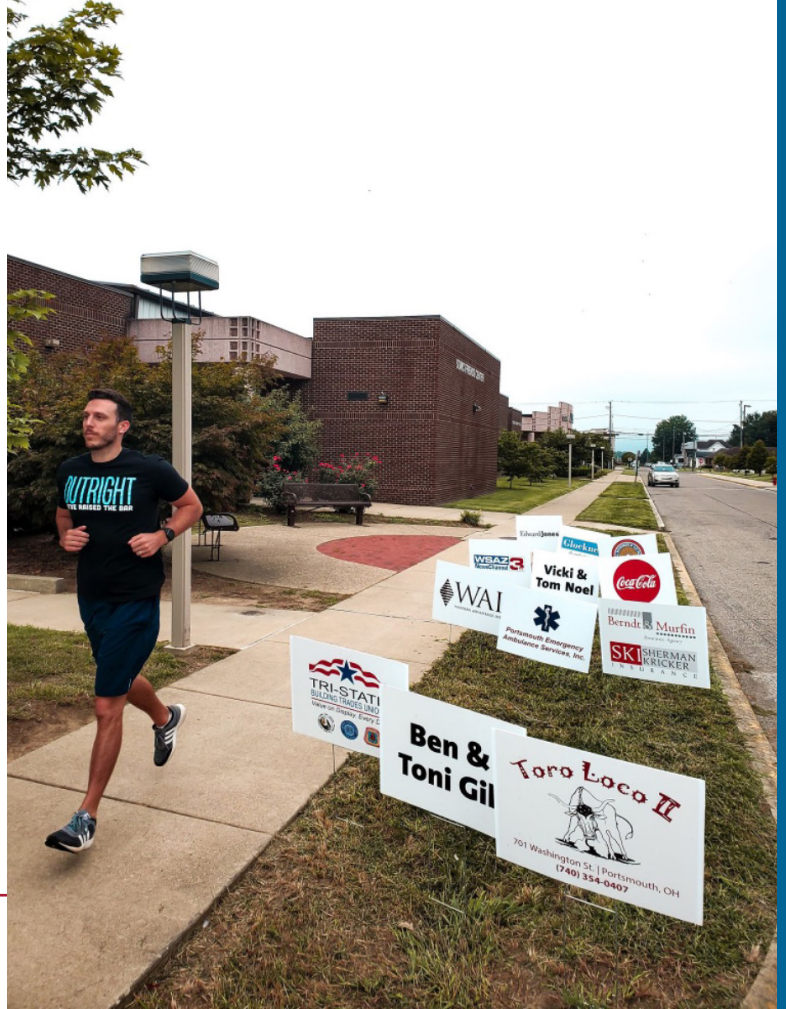

Proceeds from the October Cruisin' Pink benefited the Cancer Compassion Fund.

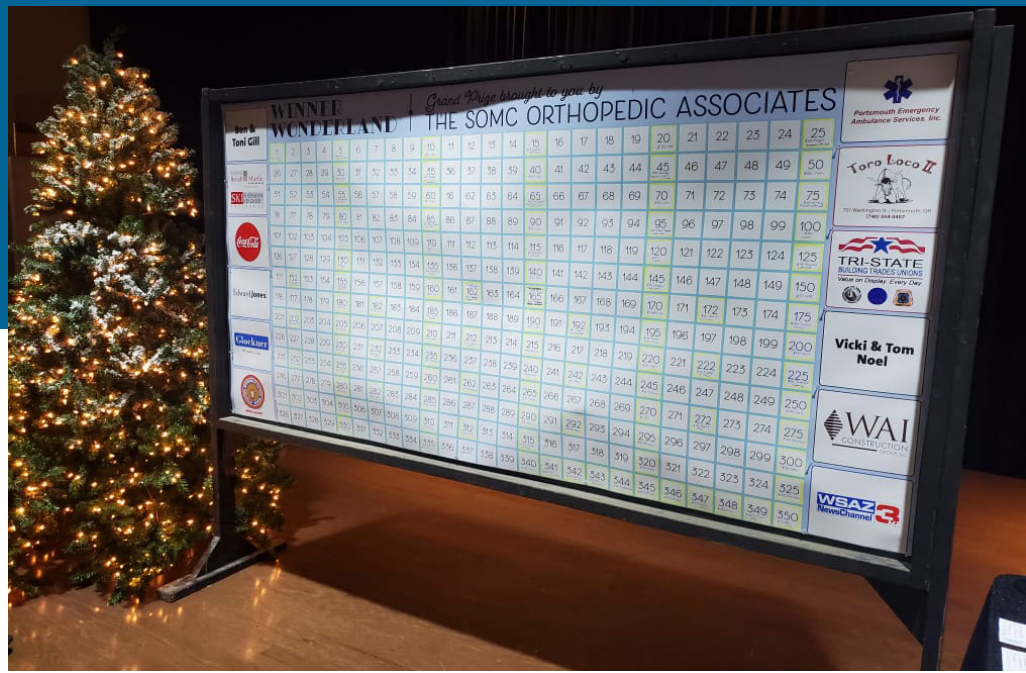

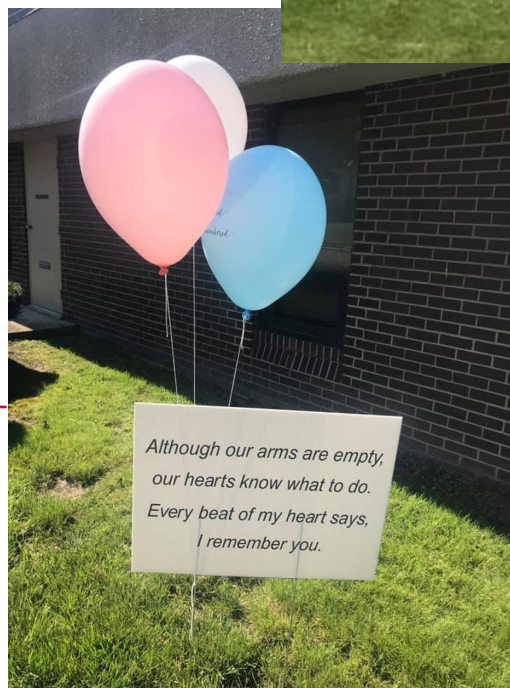
# Perinatal Loss Walk

# FY 2021 Headlines

## Jerry Bear

Jerry Bear is not only a teaching tool for children with Type 1 but also for the entire family and community. Through interaction with Jerry – using the free app and virtual tools to check his blood sugar, make food selections, carb count and administer insulin

– children learn how to take care of him and in the process themselves.

The story-driven Jerry, complete with 21 e-books include adventures with Jerry’s friends, glucose and insulin, encourages engagement between child and toy. Jerry comes with 8 injection sites and a free app which includes 21 interactive e-books and tools (pen/pump/



glucometer). These stories correlate to learning a new diabetes lesson and are “unlocked” when a child successfully completes a management task.

Ten Jerry Bears were given pediatric patients with Type 1 Diabetes. Funds were provided by the SOMC Juvenile Diabetes Fund.

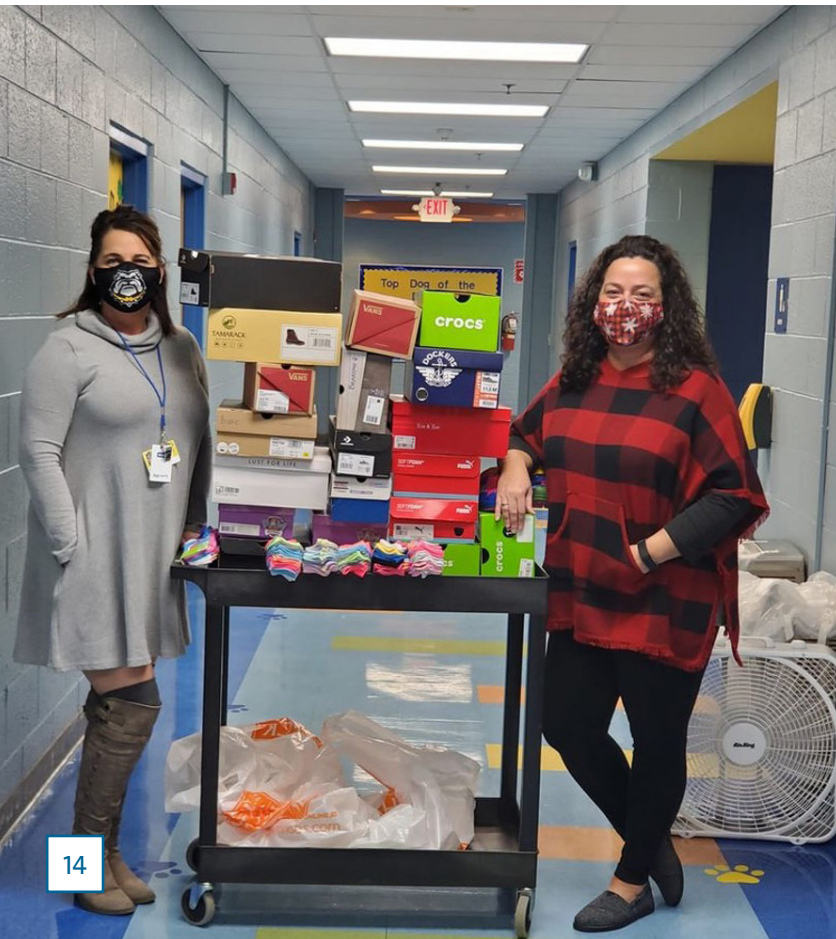
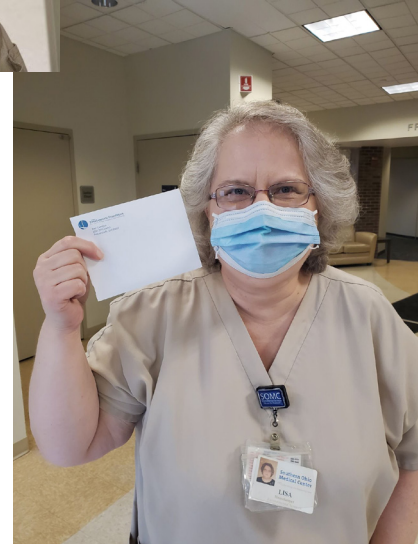
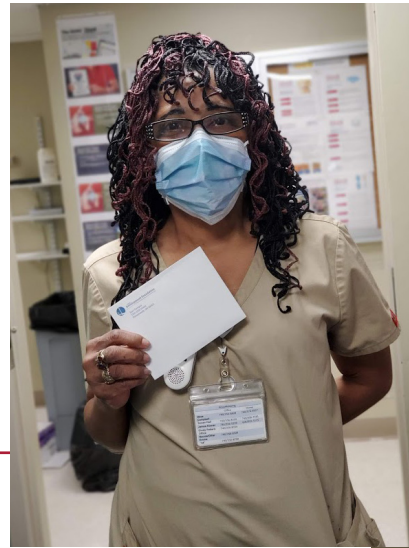

# Feed the Frontline & COVID-19 Emergency Relief Fund

With COVID-19 hitting our community hard, new giving opportunities were created to support our staff and community.

Yearly, SOMC conducts a “Scrip Card Sale” event that allows employees to purchase gift cards and have the amount payroll deducted. The event is a fundraiser for the SOMC Friends Center, but also generates a quick burst of commerce for the local economy.

The fiscal year 2021 events resulted in nearly \$68,000 in gift card sales for local businesses. The participating businesses give that participate in the Scrip program give a percentage of sales back to the SOMC Friends Center.

“The Scrip Sale is great for employees because it gives them immediate access to hundreds, or even thousands of dollars in gift cards for the price of just dollars-per-pay,” Kelli Johnson, coordinator of the SOMC Friends Center said. “It’s also great for the local economy because it encourages people to dine at local restaurants and shop with local businesses.”

# The New Wing of the SOMC Hospice Center is Complete!

After completing the SOMC Hospice Expansion Project, Transcending Lives Campaign, construction on the existing SOMC Hospice Center began.

The newest wing of the Hospice Center is open for patients and families. With four new patient rooms, a family gathering area, meditation room, staff support areas, an outdoor sitting space, shower facilities for family members, and more, there is so much to be thankful for. This project would not be possible without the generosity of our donors.

Now that the new wing has been completed, a remodel of the existing three wings will take place. During this time, the Hospice Center will continuously operate with 12 patient rooms. When construction is complete, there will be a total of 16 available patient rooms.

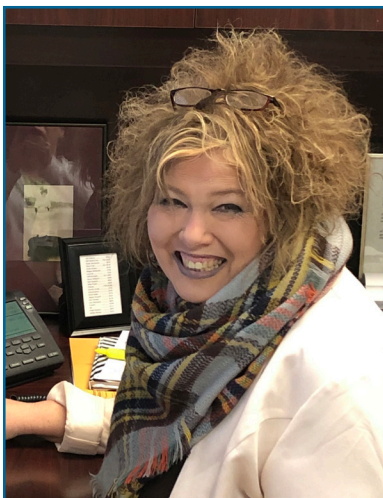
